## Hong Kong Shines Bright as a Family Office Hub

As a global offshore wealth management center, Hong Kong is ranked second worldwide after

Switzerland. In fact, the city is the fastest-growing major wealth management center in the world for international asset management. It is home to more of the world's top 500 family enterprises than any other financial hub in the Asia-Pacific region.

Given that wealth and asset management is a big part of a family office's function, the expertise, scale and depth of market offered by Hong Kong is a major draw for wealthy families. It has 70 of the world's top 100 asset managers, with more than 42,000 practitioners in the asset and wealth management business. Hong Kong is also the largest cross-border private



wealth management and hedge fund center, second only to mainland China as a center for private equity.

For ultra-high-net-worth (UHNW) families, managing and preserving their wealth is paramount. The job of a family office is to manage a family's affairs, largely through wealth and asset management, succession and legacy planning, tax and legal issues, public reputation management and philanthropy. A family also needs to contend with external forces, such as technological disruption and deglobalisation, as well as global financial and economic uncertainty.

### Hong Kong's Innovation and Technology Startup Ecosystem Revs Up

Hong Kong is going full steam to ramp up its I&T capabilities, turning the city into one of the most desirable destinations for startups. There are many different funding schemes specially designed to provide support for startups of various nature and at various stages.

To accommodate the anticipated uptick in startups, the 87-hectare Hong Kong-Shenzhen Innovation and Technology Park will begin to roll out in phases starting end-2024. Hong Kong's position in the Guangdong-Hong Kong-Macao Greater Bay Area is another great attraction for I&T startups.

Long known for its record-setting art auctions that rival sales in New York and London, Hong Kong is emerging as a vibrant international arts hub, home to a growing number of world-class museums, galleries, and cultural events, and an ecosystem that's incubating a young generation of talent.

The city's burgeoning arts scene is a reflection of Hong Kong's unique heritage and blend of Asian and Western cultures, as well as its ability to adapt to new trends and ideas.

## YRD Companies Actively "Go Out" to Expand International Business



Despite sluggish global economic growth and ongoing geopolitical tensions, many Chinese companies remain keen on "going out" to invest in a bid to expand into overseas markets and find more growth drivers. Figures recently released by the Ministry of Commerce, the National Bureau of Statistics and the State Administration of Foreign Exchange show China's overall outward foreign direct investment (FDI) reaching US\$163.1 billion in 2022, second only to the United States and accounting for over 10% of global outward FDI for seven consecutive years. At the end of 2022, the outward FDI stock from China reached about US\$2.75 trillion, ranking among the top three in the world for six years running.

Outward FDI from the Yangtze River Delta (YRD) region has always been a frontrunner among all mainland provinces and municipalities. In China's non-financial outward direct investment, US\$86.05 billion came from local enterprises, accounting for 61% of overall outward FDI (up 3.3% year-on-year). Zhejiang, Shanghai and Jiangsu ranked first, third and sixth in China's outward FDI with 17.7%, 12.4% and 6.7% shares respectively, suggesting that the YRD is one of China's major sources of outward FDI.

Over the years, Hong Kong has been the most important platform through which mainland companies venture into overseas markets. Many YRD enterprises use Hong Kong as a "going-out" platform for managing and investing in overseas business. In 2022, as much as 59.8% of China's overall outward FDI was destined for Hong Kong. The mainland's FDI stock in Hong Kong accounted for 57.7% of China's total at the end of 2022.


